

The Planning Hierarchy in Ontario

The Ontario Planning Act

- □ Applicable Laws: Endangered Species Act, Building Code Act, Clean Water Act, Aggregate Resources Act, Conservation Authorities Act, Drainage Act etc...
- Applicable Plans and Agreements: Growth Plan for Northern Ontario, Remedial Action Plan, etc...
- Applicable regulations/manuals MOECC D-series Guidelines, MNR Natural Heritage Resource Manual etc...

Provincial Policy Statement (PPS) (2014)

- "Shall Be Consistent With"
- Official Plan
 - Development Vision Land Use, Environmental, Hazards, Economic, Social...
- Zoning By-law
 - Committee of Adjustment
- Site Plan Control

Official Plan Review 2015

Current OP approved in 1996

□ Prior to:

- PPS 2005/2014
- Updated Natural Heritage Resource Manual
- Endangered Species Act
- Clean Water Act
- Planning Act and Provincial Policy requires the OP to undergo a 'Comprehensive Review' every 5 years.
 - Conformity with Amended Legislation, Plans, Agreements, PPS
 - Update to reflect changing community vision, development needs and trends.



Official Plan Review Process & Timeline

Public input in critical:

- In determining the community's overall development goals
- Ensuring public support of policies to aid implementation
- Planning Act requires 2 public meetings
 Planning Division is proposing a comprehensive outreach campaign based upon current Draft OP.



Official Plan Review Process & Timelines

Summer 2015

Informal' /Introductory discussions with Stakeholders & public.

Fall 2015

- Release of updated Draft OP
 - Updates based upon 'informal' /introductory discussions/comments

Winter/Fall 2015/2016

- □ Formal 'Statutory' Public Meeting(s)
- Formal request for comments upon updated Draft
- Council Adoption
- Provincial Approval (likely 6-12 months)



Draft Official Plan Vision and Strategic Directions

- Vision s.1.1
 - Promote efficient development patterns
 - Infill and Intensification
 - Focus growth to within Urban Settlement Area, especially the Downtown.
- Strategic Directions s.2.0
 - Building a strong sustainable community
 - Environmental Sustainability s.2.2



Draft Official Plan Natural Heritage Policies

- Significant Natural Habitats, Features and Areas
 - Fish Habitat s.3.2.1
 - \Box Wetlands s.3.2.2
 - Endangered and Threated Species and their Significant Habitats – s.3.2.3
 - Significant Wildlife Habitats
 - Deer Wintering Area s.3.2.4
 - Rare Species Occurrences s.3.2.5
 - Evaluating Potential for Significant Wildlife Habitats s.3.2.6
