- Background: This project was launched in late 2013 in response to specific actions outlined in the Stage 2 RAP Report (2002). A series of recommendations were made on how rapids habitat / wetlands habitat could be enhanced within the AOC.
- The purpose of this feasibility study is to look at those recommended actions and determine which
 ones are feasible. A lot of work went into the recommendations but EC wanted to take it to the
 next level to see what was ecologically, economically and physically feasible, as well as create
 specific details around the options and ultimately figure out which of the potential options could be
 worked towards in the future.
- The full report (that the presentation is based on) is currently out for review with the agencies who
 have a direct role (whether as a potential funder or land owner or regulatory agency) for comment.
 Once the comments are received, the report will be revised and the final copy will be shared with

the BPAC.
